Guide For New Home Builders

Follow this list, in order, for permitting procedures.

All county lines listed may be reached from our Cleveland line: 330-225-7100 + ext, or the Akron line: 330-336-6657 + extension. The extensions for the county offices are the last 4 digits of their local number.

1. **LOT NEEDS TO BE RECORDED AT THE RECORDER'S OFFICE** 330-725-9782 located in the County Administration Building at 144 N. Broadway, Medina OH 44256.
2. **GO TO TAX MAP OFFICE FOR ADDRESS TO BE ASSIGNED AND RECEIVE TAX MAP ADDRESS SLIP.** 330-725-9777 located in the County Administration Building at 144 N. Broadway, Medina OH 44256.
3. **SITE EVALUATION OF LOT WILL BE NEEDED (FOR HOUSEHOLD SEWAGE TREATMENT SYSTEM)**
Contact the Medina County Health District 330-723-9523 located at 4800 Ledgewood Dr., Medina.
If approved, continue with items numbered 4-13.

4. **WATER/SEWAGE SYSTEMS**

a) **Approval Slips For Building And Zoning:** Bring these slips when completing numbers 8 and 10. Contact the Medina County Health District 330-723-9523 located at 4800 Ledgewood Dr., Medina.

b) **Sewer / Water Permits(S) And Connection Charges:**

Obtain from appropriate department.

Zoning and building departments need the following before they will issue their permits.

5. **MEDINA COUNTY HIGHWAY ENGINEERS**

Permits are obtained from the Medina County Highway Engineer's Office, 791 West Smith Rd Medina, OH. 330-723-9568

a) **Stormwater Management And Sediment Control Permit** Permit and Fee needed whenever 5,000 sq. ft. of soil is being moved. (Includes lawn, basement, drive, landscaping, trenching for all utilities, grading or clearing.)

b) **Flood Zone Requirements**

- 6. **POND PERMITS** Ponds for drinking water supply must be approved by the Medina County Health District. When building a pond contact the **MEDINA COUNTY SOIL & WATER CONSERVATION DISTRICT OFFICE** at 6090 Wedgewood Rd. Medina, OH 44256. Permits may be obtained from either 330-722-2628 the Soil & Water office **or** 330-723-9568 the Medina County Highway Engineer's Office at 791 West Smith Road, Medina, Ohio 44256. A pond plan review and site inspection will be completed by one of these offices depending on the watershed size of the pond. A permit is then issued by the Medina County Highway Engineer's office and is then taken to the proper Township Zoning Inspector.
- 7. **DRIVEWAY OR CULVERT PERMIT:** A permit is required if work is being done in the right-of-way on a new or existing driveway. Medina County Highway Engineer issues permits for any drive located on County roadways or on Township maintained roads *EXCEPT* in the following Townships: **SPENCER, CHATHAM and MONTVILLE**. Permits and fees are required for new or existing drives, for updating past due permits, and for any surfacing, widening, repair, or replacements on existing drives. Permits are obtained from the Highway Engineer's Office 330-723-9568 at 791 W. Smith Road Medina, OH.

NOW THAT YOU HAVE ALL THE ABOVE COMPLETED, YOU OR YOUR CONTRACTOR CAN FULFILL THE REST OF THE REQUIREMENTS.

- 8. **ZONING PERMIT** Bring all numbers 1 through 7 (permits and information) along with the site plan and prints to the appropriate Zoning Clerk for your Township or Village. Zoning numbers are listed on <http://building.medinaco.org> under "contact us".
- 9. **ENERGY CODE COMPLIANCE-** may be met several ways. Information is listed on <http://building.medinaco.org> under "Documents" then click "Guides," under Residential click "Energy Compliance Statement"
- 10. **BUILDING PERMIT** Visit <http://building.medinaco.org> and complete your permit application on line or bring in a set of plans and plan review fee of \$65.55 to the Medina County Building Department located at 791 West Smith Rd Medina, OH. **Residential Plan review averages 3-5 days.**
- 11. **ELECTRICAL AND MECHANICAL PERMITS** Issued at the Medina County Building Department, 330-722-9220, located at 791 West Smith Rd. Medina, OH. All applicants must provide proof of State license (copy of OCILB), unless the job qualifies under a homeowner's exemption.
- 12. **OTHER PERMITS** After the Building Permit is issued then permits for plumbing, and on-site sewage system, and water supply are issued by the Medina County Health District, 330-723-9523, located at 4800 Ledgewood Drive Medina, OH.

13. FINAL OCCUPANCY SHALL NOT BE GRANTED UNTIL AT LEAST THE FOLLOWING FINAL APPROVALS HAVE BEEN OBTAINED:
